State Bank of India Market Cap Crosses ₹8 Lakh Crore Milestone

State Bank of India (SBI) reached a big milestone when its market capitalization went over ₹8 lakh crore.

This was made possible by a huge rise in the price of its shares. This accomplishment shows how well the bank has been doing and shows that investors are confident in the banking industry as the market is doing well.

The rise in SBI's stock price and market value

During trade, SBI's shares went up almost 10%, which made the company's market value go over ₹8 lakh crore for the first time.

The rise in stock prices was caused by a recovery in the market as a whole. Benchmark indices hit all-time highs as people felt good about the election results.

Impressive Measures of Performance

The tremendous growth of SBI's stock, which has increased by more than 50% in the last six months, is proof of its great success.

Also, the bank's year-over-year net profit growth of 24% in Q4 and 3% rise in net interest income were better than what analysts had expected.

The quality of SBI's assets has also gotten better, as shown by the fact that the gross NPA ratio has gone down to 2.24%.

Karnataka Vikas Grameena Bank Gets National Award for APY Implementation

The Pension Fund Regulatory and Development Authority (PFRDA) gave Karnataka Vikas Grameena Bank (KVGB), a regional rural bank backed by Canara Bank, a national award for a lot of people signing up for the Atal Pension Yojana (APY).

Who was given this award?

The award was given to Shreekant M. Bhandiwad, Chairman of KVGB, on June 21 in New Delhi by Vivek Joshi, Secretary, of Department of Financial Services, Government of India, and Deepak Mohanty, Chairman of PFRDA.

APY gives workers in the private sector a safety net by guaranteeing a pension after 60 years.

ICICI Bank M-Cap Tops \$100 bn; Becomes Only Sixth Indian Co to Hit Milestone

The market value (m-cap) of ICICI Bank passed \$100 billion for the first time on June 25. It was only the sixth company to do so.

Along with Reliance Industries, Tata Consultancy Services, HDFC Bank, and Bharti Airtel, the private sector lender is now part of the group.

The four other companies named in the United States that are worth more than \$100 billion on the stock market.

ICICI Bank's success comes after Infosys

In the past, Infosys had also reached the goal. Following a record high of Rs 1,207, ICICI Bank shares last finished at Rs 1,199, up 2.5%, putting the value of the company at Rs 8.44 trillion (\$100 billion).

ICICI Bank's share price has gone up almost 29% in the past year, more than the 27% rise in the NSE Nifty 50 and the 20% rise in the Bank Nifty.

The first quarter of FY25 data from ICICI Bank will be released by the bank's board of directors on July 27, 2024.

ICICI Bank's standalone net profit rose to 10,707.5 crore in the last quarter, which finished on March 31.

This is up 17.4 percent from Rs 9,121.9 crore in the same quarter last year. In the January-March quarter, it made Rs 19,092.8 crore in net interest income, up from Rs 17,666.8 crore the previous year.

There was also a dividend of Rs 10 per stock share with a face value of Rs 2.

NPCI International and Reserve Bank of Peru Forge Landmark Partnership for UPI Payments

NPCI International and the Reserve Bank of Peru have teamed up to create a real-time payments system in Peru that works like UPI. This is a first for South America. Using India's well-known Unified Payment Interface (UPI) technology, this partnership aims to change Peru's financial scene in a way that encourages economic growth and financial inclusion.

A Look at the Partnership

The Central Reserve Bank of Peru (BCRP) and NPCI International have announced a groundbreaking agreement to build a real-time payments system in Peru that works like UPI.

This strategic partnership makes Peru the first country in South America to use UPI technology, which will make the country's banking system more efficient and easy for everyone to use.

Goals for the future

The goal of the partnership between NPCI International and the BCRP is to strengthen Peru's banking system so that digital payments can help the economy grow.

Together, they want to encourage people to have access to financial services, cut costs, and be open about things, while also being flexible enough to adapt to new technologies and market needs.

SBI Distributes Rs 6,959 Crore Dividend to Government

The Indian government got a dividend of Rs 6,959 crore from the State Bank of India (SBI) for the financial year 2023–24. This is a big financial move.

The payment went up from Rs 11.30 per share last year to Rs 13.70 per share this year. The dividend check was given to Finance Minister Nirmala Sitharaman by SBI Chairman Dinesh Kumar Khara. Financial Services Secretary Vivek Joshi was also there. For the year, SBI had a record combined net profit of Rs 67,085 crore, up from Rs 55,648 crore the year before.

India's Environment Performance in 2024

India is ranked 176th out of 180 countries in the Environmental Performance Index (EPI) for 2024.

This is a little better than the previous year's ranking, but it still puts it among the world's worst offenders.

The measure, which was made by Yale and Columbia universities, shows how badly India is doing in important areas like biodiversity, air quality, and greenhouse gas emissions.

Placed 10th on the Environmental Performance Index 2024 list,

- Score for Luxembourg: 75.0
- Score for Germany: 74.6
- Score for Finland: 73.7
- Score: 72.7 for the UK
- Sweden got 70.5 points,
- Norway got 70.0 points,

- Score for Switzerland: 68.0
- Score for Denmark: 67.9

Delhi Airport Launches India's First Self-Service Mechanism For Check-in Luggage

The Delhi International Airport Ltd started a self-service system on June 17 so that people could drop off their bags, get tags, and print their boarding passes without having to wait for someone else to do it.

Setting up a self-service bag drop (SSBD)

About 50 Self-Service Bag Drop (SSBD) units have been set up at Delhi's IGI Airport for people to use in Terminals 1 and 3.

These units are shared by Air India, IndiGo, and Air India Express.

How does this system work?

With this new system, passengers can get their luggage tags and connect them at CUSS kiosks when they arrive.

After the passengers put their bags on the SBD conveyor belt, the system starts the app for that airline on the SBD machine with a single click.

The DIAL also said that when a passenger agrees to the dangerous goods self-declaration form with just one click, the SBD system checks all the important criteria and business rules set by the airlines.

India Set to be the 6th Country to have its own Deep Sea Mission

With the commencement of its ambitious Deep Sea Mission, India is going to become the sixth country to embark on such a ground-breaking project, joining an elite group of nations that are already at the forefront of their respective fields.

During a recent meeting in New Delhi, Dr. Jitendra Singh, who is the Union Minister of State (Independent Charge) for Science and Technology, Earth Sciences, PMO, Atomic Energy, Space, Personnel, Public Grievances, and Pensions, expressed his pride and happiness over the progress that has been made about this mission.

How to Achieve a Blue Economy That Is Resilient

Dr. Jitendra Singh, who was in charge of presiding over a conference to review the 100-day Action Plan of the Ministry of Earth Sciences, underlined the significance of concentrating on the development of a resilient blue economy to empower individuals whose livelihoods are based on the ocean and the energy it provides.

He brought attention to the fact that the Deep Sea Mission is not restricted to the investigation of minerals alone; rather, it involves the growth of ocean sciences, the exploration of flora and fauna, and the conservation of marine biodiversity.

Supreme Court Reconstitutes Gender Sensitisation Committee

In line with the Gender Sensitization and Sexual Harassment Regulations of 2013, the Supreme Court of India has once again set up its Gender Sensitization and Internal Complaints Committee.

The Chief Justice of India started the process of reorganizing, and Justice Hima Kohli is now the Chairperson. Justice BV Nagarathna is now a Member, and Dr. Sukhda Pritam is now the Member Secretary.

Details about membership

There are lawyers on the group from the Supreme Court Bar Association, the Supreme Court Advocate-on-Record Association, and the Supreme Court Bar Clerks' Association, among others.

Members also include lawyers and academics like Shruti Pandey, Jaideep Gupta, Dr. Leni Chaudhuri, and Dr. Menaka Guruswamy, who were chosen by the Chief Justice of India.

This makes sure that the Supreme Court Gender Sensitization and Internal Complaints Committee has a stable leader.

India is the World's Second Largest Emitter of Nitrous Oxide

India is the second biggest source of nitrous oxide (N2O) in the world. N2O is a greenhouse gas that warms the air much more than carbon dioxide. Nearly 11% of these man-made emissions around the world in 2020 came from India.

China had the most, at 16%. A study of N2O emissions around the world, which came out in the journal Earth System Science Data on June 12, says that fertilizer use is the main source of these emissions.

Details and a Report

The study said that the amount of N2O in the air, which is the third most important greenhouse gas, is rising faster than the Intergovernmental Panel on Climate Change (IPCC) thought it would.

In 2022, the concentration hit 336 parts per billion, which is 25% more than it was before industrialization and a lot faster than the IPCC thought it would rise.

Over the past ten years, world carbon dioxide emissions from fossil fuels and changes in land use have stayed pretty stable. On the other hand, global N2O emissions keep going up, mostly because of food production.

The five countries that put out the most manmade N2O in 2020 were China (16.7%), India (10.9%), the US (5.7%), Brazil (5.3%), and Russia (4.6%).

South India's First Leopard Safari Opens at Bannerghatta

It was just opened by Eshwar Khandre, the Environment Minister, at the Bannerghatta Biological Park (BBP) in Bengaluru as South India's first and largest leopard tour. This big event marks a turning point in India's work to protect wildlife and boost wildlife tourism.

The safari takes place on a 20-hectare area that follows the strict rules set by the Central Zoo Authority for safety and to look like an environment.

The Safari's history and features

It took 4.5 crore to build the leopard safari, which is meant to look like the leopards' natural environment, with rolling hills, rocky outcrops, and woods that lose some of their leaves in the fall.

The enclosure is sealed with a 4.5-meter-tall chain-link mesh and MS sheets that are raised at a 30° angle. It's set up this way so that both the leopards and the tour guests are safe.

Leopards and people who live in safari areas

The BBP is home to many leopards, and eight of them are set free for the first time. This safe place lets people get close to these beautiful animals, which helps spread the word about leopard protection and teaches people how to do it.

This is also backed up by the park's plan to take care of saved leopard cubs and help them get used to safari life before moving them to a place closer to where they belong in the wild.

India Created World Record with 64.2 crore People Voting in Lok Sabha Poll

India set a new world record by having 64.2 crore votes, including 31.2 crore women, take part in the Lok Sabha Election 2024.

CEO Rajiv Kumar said that the number of voters is 1.5 times the total number of votes in the G7 countries, which are the US, UK, France, Germany, Italy, Japan, and Canada.

It is also the world record for the most women voters (31.2 crore), who went to the polls for the Lok Sabha.

He also said that there were only 39 recounts in this race, compared to 540 recounts in the 2019 General race.

Mr. Kumar said that more than 68 thousand monitoring teams and 1.5 crore poll workers and security guards were part in the election. He also said that, with a turnout of 58.58 percent generally and 51.05 percent in the Valley, Jammu and Kashmir had its best turnout in forty years.

India and the World

This year, polls are planned in more than 80 countries, and some of them are already over. There are some of the richest and strongest, as well as the most crowded, authoritarian, and weak countries on this list. A lot of these votes would see how far democracy can go, while others would just be rubber-stamping exercises.

Two bird Sanctuaries of Bihar added to Ramsar List

The number of Ramsar Sites in India has grown to 82 with the addition of two bird reserves from Bihar.

These are called Nagi and Nakti. On June 5, which is World Environment Day, two new "Wetlands of International Importance" were added to the Ramsar List. They are man-made lakes in the Jhajha forest area of the Jamui District in Bihar.

Why Nagi and Nakti Bird Sanctuary Is Important

In the Jhajha forest area of Jamui, these two new wetlands are man-made lakes. The Secretary of the Department of Environment, Forest, and Climate Change (DEFCC) of Bihar said, "Their catchments are made up of dry deciduous forests surrounded by hills."

India's First Biosphere in a Tiger Reserve

People who care about the earth, Jai Dhar Gupta and Vijay Dhasmana The Rajaji Raghati Biosphere (RRB), which is in the Rajaji National Park in Uttarakhand and is India's first biosphere, was made in a tiger reserve.

About Biosphere

The biome is in Uttarakhand's Rajaji National Park. It looks out over the rocky, white Raghati riverbed, which is in the foothills of the Shivalik range.

The biosphere is a 35-acre private forest project that aims to find and bring back to life rare and endangered species of local trees while keeping the area safe from mining and poachers. Before it was set aside for RRB, the land was empty and in bad shape.

Om Birla Becomes First Lok Sabha Speaker in 20 Years to be Re-elected as MP

It was an amazing accomplishment for Om Birla, who is currently the Speaker of the Lok Sabha, to win the spot in Kota on June 4, 2024.

Birla was re-elected to the Lower House of Parliament with a huge majority of 41,139 votes. She is the first presiding officer to do so in 20 years.

Putting an end to a 20-year drought

In the 11th Lok Sabha, from 1996 to 1998, P.A. Sangma was Speaker and also won reelection to the Lower House.

He was the last Speaker to do so. At that time, Sangma was a member of the Congress party. In the 1998 Lok Sabha election, he was re-elected from Tura in Meghalaya.

MoD Signs MoUs to Expand SPARSH Service Centers

By forming relationships with four well-known banks, the Ministry of Defense (MoD) has taken a big step toward improving services for pensioners.

The goal of these Memorandums of Understanding (MoUs) is to set up SPARSH service centers across 1,128 branches across the country by using the System for Pension Administration (RAKSHA).

A web-based method called SPARSH makes it easier to process pensions and send money directly to the bank accounts of defense pensioners.

Improving access for pensioners

The MoUs with Bank of India, Canara Bank, Central Bank of India, and Utkarsh Small Finance Bank are a smart move to connect pensioners in the last mile, especially those who live in remote places that don't have good technology.

These SPARSH service centers will be important hubs for retirees, helping them with things like updating their profiles, filing grievances, digital annual identification, data verification, and getting access to detailed pension information.

School Education Department Signs MoU with National Book Trust to Create Institutional Framework for Rashtriya E-Pustakalaya

The Department of School Education and the National Book Trust signed an MoU to set up the institutions that will support the Rashtriya e-Pustakalaya Digital Library Platform. K. Sanjay Murthy, Secretary of the Department of Higher Education, said that the Rashtriya e-Pustakalaya will be open 24 hours a day, seven days a week, so fans can get their books whenever they want.

He also said that Rashtriya e-Pustakalaya would solve the problem of many states not having a library in the last mile.

An online library platform

In the next two to three years, the digital library plans to give over 10,000 books in more than 100 languages, solving the "last mile" problem for many states.

There are now more than 1,000 books offered in 23 languages.

What Rashtriya e-Pustakalaya wants to do

The Rashtriya e-Pustakalaya will have more than 1,000 non-academic books from more than 40 companies, written in 22 languages besides English.

The platform will be available on Android and iOS devices and geared toward four age groups: 3 to 8, 8 to 11, 11 to 14, and 14 to 18.

This is in line with NEP 2020 standards. The library will have books from a variety of genres, which will help people understand and respect other cultures.

The project, which aims to close the digital gap, will ensure that books can be accessed anytime and anywhere, encouraging young people to develop good reading habits.

The MoU means that both countries will work together to make India a better place to learn.

India to host 2025 FIH Hockey Men's Junior World Cup

The International Hockey Federation's Executive Board chose India to hold the first-ever Junior World Cup in December 2024.

The FIH Hockey Men's Junior World Cup was last held in 2023 in Malaysia, and Germany won it.

The FIH Hockey Junior World Cup will have 24 teams for the first time.

State-related Affairs

Pench Tiger Reserve launches first advanced AI System for forest fire

An innovative artificial intelligence system has been implemented at the Pench Tiger Reserve in Maharashtra for early detection of forest fires. In addition to having a viewing range of fifteen kilometers, this cutting-edge device is equipped with a high resolution camera. The hill that the tower is situated on is located near the settlement of Kirringisarra. There was funding for a portion of the project provided by Solar Industries India Ltd., Nagpur, and the government of Maharashtra.

Haryana Government's Rs 10,000-Crore Project to Combat Air Pollution

T V S N Prasad, the chief secretary of <u>Haryana</u>, announced the start of a Rs 10,000-crore project to clean up the state's air. The World Bank will pay for the project.

The National Capital Region (NCR) will be the first place where the Haryana Clean Air Project for Sustainable Development is put into action.

Improving the infrastructure for monitoring air quality

The first part of the project is to improve Haryana's systems for tracking air quality. Setting up a state-of-the-art lab and updating old ones are both parts of this.

A separate unit for program management will also be in charge of execution, and training programs will be set up for people who have a stake in managing air quality.

International Affairs

Volvo to Issue World's First EV Battery Passport Ahead of EU Rules

Volvo Cars is releasing the world's first EV battery passport, which carefully tracks the raw materials, parts, recycled content, and carbon footprint of its upcoming top EX90 SUV, even before EU rules become law.

A QR code on the inside of the driver's door lets Volvo drivers get to a simplified version of the passport.

What the EV Battery Passport Does

Volvo and the UK-based startup Circulor worked together to make the EV battery passport. Circulor uses blockchain technology to map companies' supply lines.



Circular's work on battery passports began before the first suggestion for a New Battery Regulation from the European Commission in 2020. For EVs sold in the EU after February 2027, the EU says that these kinds of passports must be offered.

Pakistan Launches New Military Operation Azm-e-Istehkam

The leaders of Pakistan have started Operation Azm-e-Istehkam, which is also called "Resolve for Stability," to fight the growing violence and terrorism that are mostly caused by their wars with Afghanistan.

Prime Minister Shehbaz Sharif took a close look at the country's anti-terrorism plans, and focused on what was learned from the National Action Plan, which was made after the terrible attack on the Peshawar Army Public School in 2014. This operation comes after that.

The goals of Operation Azm-e-Istehkam

The main goal of Operation Azm-e-Istehkam is to make the country safer by fighting threats from inside and stopping armed fighters from leaving Afghanistan.

Sharif's office says that the action will "intensify" attacks on terrorists. It will use economic and social strategies to make people happy and stop the spread of radical ideas.

The plan also wants to protect law enforcement agencies legally, which will help with prosecutions and handling cases linked to terrorism.

Paraguay Becomes 100th Member of International Solar Alliance as 100th Member

Paraguay is now the 100th full member of the <u>International Solar Alliance (ISA)</u>. This is a big step forward in working together on solar energy around the world.

Its headquarters are in India, and its mission is to remove barriers in technology, finance, and ability that stop the global spread of solar energy.

Leadership and Projects in India

While India was president, the ISA worked on important projects all over the world.

For example, infrastructure in Malawi and Fiji was made solar-powered, and buildings were built in Seychelles and Kiribati that use solar power. India supports clean energy options by sharing technology, building up people's skills, and making bilateral agreements within the ISA structure.

G7 Agrees \$50bn Loan for Ukraine Using Russian Assets

The G7 has decided to use Russian assets that have been frozen to get Ukraine a \$50 billion loan to help it defend itself against a <u>Russian</u> invasion.

President Vladimir Putin called it theft, while US President Joe Biden said it was a strong stand against Russia.

President Volodymyr Zelensky of Ukraine and President Biden signed a 10-year security deal in Italy at the G7 meeting.

The decision, which was brought up by Ghana, stresses the importance of using quantum technologies for sustainable development in areas like medicine, renewable energy, financial inclusion, and safe communication.

A quantum computer will be built in Brisbane by PsiQuantum.

Denmark Set to Impose World's First Carbon Tax on Gassy Cattle

To make history, Denmark will be the first country to tax farmers who raise animals starting in 2030. The goal of this project is to reduce the methane emissions that come from cows, sheep, and pigs, which are major causes of global warming. Denmark wants to cut its greenhouse gas emissions by 70% from what they were in 1990 by the year 2030.

The first country to charge a tax on carbon

Denmark is going to be the first country to put a carbon tax on methane emissions from animals. This is because methane is a very strong greenhouse gas. This innovative plan aims to cut greenhouse gas pollution by a lot and encourage other countries to do the same. Denmark's farming minister, Jacob Jensen, said, "We are writing a new chapter in Danish agricultural history" to emphasize how important the deal was. The plan includes big funds for the green transition in agriculture, which are meant to show that the country is serious about using sustainable farming methods.

Foreign Relations

India Participates in the Summit on Peace in Ukraine

India was represented at the Summit on Peace in Ukraine, held in Burgenstock, Switzerland, on June 15 and 16, 2024, by Shri Pavan Kapoor, Secretary (West) in the Ministry of External Affairs.

India went to both the opening and closing plenary sessions of the Summit, but it did not agree with any documents or communiques that came out of them.

This shows that India has always taken a strong, independent stance in favor of using dialogue and diplomacy to end the war peacefully.

India's presence at the Summit and in earlier meetings between the NSA and Political Directors based on Ukraine's Peace Formula shows its dedication to a long-lasting and peaceful solution.

India wants the sides to the conflict to engage in honest and useful talks. They stress that dialogue and diplomacy are very important for making peace last.

64th International Sugar Organisation Council Meeting in New Delhi

The 64th meeting of the International Sugar Organization (ISO) Council began on June 25, 2024, at Bharat Mandapam in New Delhi.

More than 30 countries' delegates and leaders from other international groups were there. The meeting, which will take place from June 25th to June 27th, 2024, is meant to talk about problems in the biofuels and sugar industries.

India as the head of ISO

At the 63rd ISO Council meeting in London, India was chosen to be Chairman of the International Sugar Council for 2024.

The Global Sugar Industry and India's Place in It

110 countries, according to the ISO, make sugar from sugarcane or sugar beets. Sugarcane makes up 80% of the world's sugar.

The top five producers are in order: Brazil, India, the EU, China, and the USA. India is the biggest consumer of sugar and the second-biggest producer of it.

It makes up about 15% of the world's sugar usage and 20% of its production. India is also the third biggest maker of ethanol, a biofuel made from sugarcane molasses, after the United States and Brazil. India's top three states for growing sugarcane are Uttar Pradesh, Maharashtra, and Karnataka.

Oracle Partners with Tamil Nadu to Empower Youth with IT Skills

When Alpana joined the RBI, it started a new era for the bank's marketing department. A former executive director said that Alpana was "integral to the evolution of the RBI's communication."

Her story is linked to the bank's efforts to control its public image and internal communications.
